1、 Brief Introduction of This Project

1) Background

Global music distribution is accelerated by rapid development of streaming music and the integration of the global music market makes music from diversified culture available at fingertips and artists more free than ever from attaching to major labels to survive. Data shows that 98.5% of artists haven't signed with companies.

As a result, the copyright protection and copyright royalties dissemination have become global problems and the growing number of independent artists calls for sound transnational supporting services.

The attributes of Blockchain technology, such as asset authentication, temper-proof data storage and transaction, and token incentive mechanism, make it the best solution to these problems. International Federation of Musicians, the world's most famous music copyright management agency, is also actively trying to adopt blockchain technology to manage and protect global copyright.

2) About Muse Network

Muse Network is committed to build a blockchain-empowered global

music ecosystem. Within this ecosystem, music copyright is protected, copyright royalty is disseminated automatically through smart contract, and music distribution is improved through interpersonal communication networks by token incentive mechanism.

Muse Network provides a comprehensive plan to create closed loops of music value and to facilitate the whole process from the creation to value realization of music including music copyright crowdfunding, music creation, music copyright authentication, music distribution, music value added, music copyright trade. Muse Network contains six parts to realize these purposes, which are Muse Network, Muse Record, Muse Copyright, Muse Toolkit, Muse Market, and Muse Community. The whole operation process is as follow:

- Copyright Authentication

Artists upload their music from the portal of Muse Record Dapp, and all of the information of this piece of music will be stored in hash upon Muse Network public chain to complete the copyright authentication.

- Music Distribution

Artists share a certain percentage of tokenized music copyright on Muse Record Dapp with their fans who are also called Angel Agents to


mobilize them to spread their music. Countless angel agents will discover good music by themselves. Artists can also talk with their fans in Muse Community to promote their music.

- Music Value Realization


When a piece of music gets popular, its copyright will add value too. Shareholders can trade their copyright share through Muse Market so that fans and artists both make profits.
